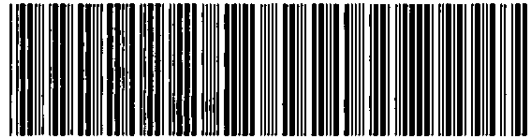

In compliance with Chapter 607 and/or Chapter 621, F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Warriors on the Wall International Ministry, Inc.

ARTICLE III PURPOSE

The purpose for which the organization is organized is:
exclusively for charitable and religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. More specifically, it was organized to build prayer centers for the purpose of interceding for the nation and the local community via conference calls and gatherings at both local facilities and places of worship. Essentially, the organization is a Christian organization that will pray and intercede, gather in recognition of Florida's National Day of Prayer on October 15th of each year, and assist those who are destitute of the basic human necessities of food, clothing, and shelter.

ARTICLE VI EFFECTIVE DATE

The effective date of the corporation is October 15, 2011, recognized as the national day of prayer in the state of Florida.

ARTICLE VII NET EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
