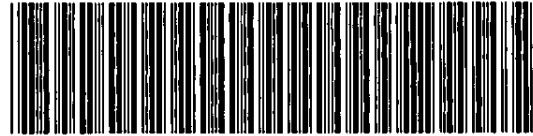

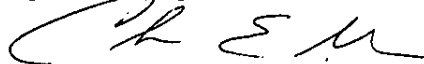

Articles of Incorporation of
WEST VOLUSIA SURGE, INC.,
a Florida Not-For-Profit Corporation

The undersigned person, acting as incorporator of a corporation not for profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following articles of incorporation for the corporation:

Article I.

The name of the corporation is WEST VOLUSIA SURGE, INC.

Article II.

The corporation shall have a perpetual duration.

Article III.

The corporation is a not-for-profit corporation. The purposes for which the corporation is organized are:

(a) The specific and primary purposes for which this corporation is formed are to foster national amateur sports competition and assist in the teaching of sports to youths.

(b) The general purposes for which this corporation is formed are to operate exclusively for national amateur sports competition which will qualify it as an exempt organization under 26 U.S.C.A. § 501(c)(3), or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Section.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements in any political campaign on behalf of any candidate for public office.

Article IV.

The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collecting dues and assessments shall be as regulated in the bylaws. The method of election of directors shall be stated in the bylaws.

Article V.

The street address of the initial office and principal office of the corporation is 510 Tera Plantation, Debary, FL 32713, County of Volusia. The mailing address of the corporation is 510 Tera Plantation, Debary, FL 32713. The name and address of its registered agent is Michael P. Nordman, Esq., 112 North Florida Avenue, DeLand, FL 32720.

Article VI.

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. The method of electing the directors is stated in the bylaws and shall be by a vote of the members.

Article VII.

The property of this corporation is irrevocably dedicated to foster national amateur sports competition and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, or to the benefit of any private individual.

Article VIII.

On the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for similar purposes and which has established its tax exempt status under 26 U.S.C.A. § 501(c)(3), or corresponding provisions of any subsequent federal tax laws.
