#### ARTICLE I NAME

The name of the corporation shall be: REALITY RANCH MINISTRIES, INC.

### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To provide therapeutic horseback riding for developmentally disabled adults and children, therapeutic horsemanship for drug addicted adults going through recovery program, and youth rodeo programs and activities for at risk youth and teens. Notwithstanding any other provisions, this corporation is organized exclusively for charitable, educational and scientific purposes, and will not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c)(3)of the United States Internal Revenue Code, as amended from time to time, (b) a corporation contributions which are deductible under Section 170(c)(2) of the United States Internal Revenue Code, as income set forth in Section 508(e) or any other section of the United States Internal Revenue Code, as amended. This corporation shall not be involved in prohibited financial transactions with disqualified persons (acts of self-dealing) per restrictions set forth in Section 494 and other provisions of the United States Internal Revenue Code, as amended. The Funds to carry out the purposes of the corporation shall be obtained through donations, and any and all means permitted under law.

# ARTICLE IV EARNINGS DISTRIBUTION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## <u>ARTICLE V ASSETS DISTRIBUTION UPON DISSOLUTION</u>

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
