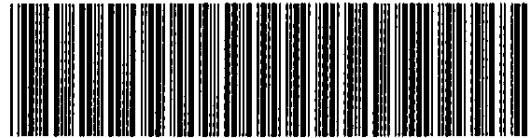

**ARTICLES OF INCORPORATION**  
**OF**  
**CLUB RECOVERY OF CITRUS COUNTY,**  
**INC.,**

*a Florida not-for-profit corporation*

**THE UNDERSIGNED**, pursuant to Chapter 617.0202, F.S., to be formed under the Florida Not for Profit Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I:** The name of the corporation (the Corporation) is:

**Club Recovery of Citrus County, Inc.**  
*A Florida not-for-profit corporation*

**ARTICLE II:** The principle place of business and mailing address of the corporation is:

**4011 – S. Tom Ave.**  
**Inverness, Florida 34452**

**ARTICLE III:** The specific purpose or purposes for which the corporation is organized:

Club Recovery of Citrus County, Inc. is a volunteer organization comprised of individuals recovering from alcoholism and/or other chemical dependency and/or emotional disease, who support abstinence as the touchstone of recovery, and are otherwise interested and active in prevention, education, treatment, and/or recovery as pioneered by Alcoholics Anonymous.

It is further the object and purpose of this organization that a sober and temperate atmosphere be acquired and or purchased and maintained whereby the members and prospective members of the organization can further improve their emotional sobriety through reading, discussion, fellowship, meetings, lectures, films, textbooks, pamphlets, and by witnessing the example of recovering alcoholics.

**ARTICLE IV:** The manner in which the Trustees are elected or appointed:

There shall be an election of Trustees by majority vote of qualifying members as established in the Corporation's By-Laws. The initial Trustees are appointed for the purpose of incorporating, elections will be held within the first year and will take place annually as directed by the membership and the Corporation's By-Laws.

**ARTICLE V:**

The number of trustees constituting the initial Board of Trustees for the Corporation is three (3), and the names and addresses of the persons who are to serve as trustees of the Corporation until the first annual meeting of the members of the Corporation, or until one or more successors have been elected and qualify, are as follows:

**ARTICLE VI:**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and any corresponding section of any future federal tax code (the "Code").

**ARTICLE VII:** The Corporation is organized under a non-stock basis.

**ARTICLE VIII:**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article **SIXTH** of these Articles of Incorporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the Corporation's Articles of Incorporation, as amended from time-to-time, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Code or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Code.

**ARTICLE IX:**

Upon dissolution of the Corporation, assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any assets of the Corporation not so disposed of shall be disposed of by the Circuit Court of the Twelfth Judicial Circuit, in and for Citrus County, Florida, exclusively for such purposes or to such organization or organizations as the said honorable Court shall determine, which are organized and operated exclusively for such purposes.
