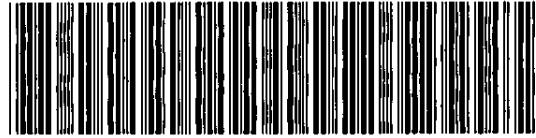

The name of the corporation is Preserve Wellington's Future, Inc. The document number of the corporation is N12000001009.

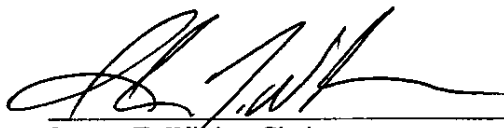
ARTICLE II
