**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions under section 501(c) 3 of the Internal Revenue Code or corresponding section of any future federal tax code.
