

Article 1

The name of the corporation is: Ministerios Manantial De Vida, Inc.

Article 2

The principal place of business address of this corporation is 14745 N. Nebraska Avenue, Tampa, Florida 33613 and the mailing address of this corporation is P. O. Box 17405 Tampa, Florida 33682, in Hillsborough County.

Article 3

- A. The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate on the basis of race, color, or national or ethnic origin.
