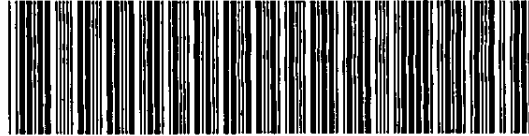

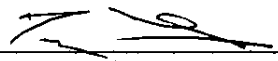

**AMENDED ARTICLES OF INCORPORATION for
ROSEDALE COMMUNITY CHURCH, INC.
In Compliance with Chapter 617, F.S. (Not for Profit)**

**ARTICLE I
NAME**

The name of the corporation shall be:

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE**

The corporation is organized exclusively for charitable, religious, educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The corporation's mission is to provide shelter to the homeless, refuge for the abused, provide educational assistance, and other related purposes.

**ARTICLE IV

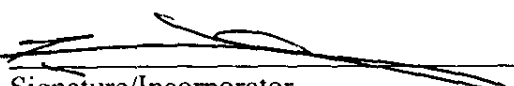
