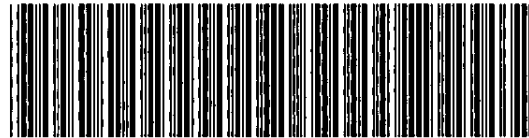

Article VIII - Supplemental Provisions/Information

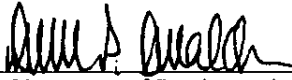
