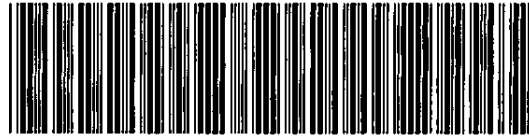

**ARTICLES OF INCORPORATION FOR NONPROFIT ORGANIZATION
OF**

KRJ Ministries, Inc.

Pursuant To Florida Statutes Chapter 617.0202, the undersigned subscriber to these articles of incorporation, all natural persons over the age of 18, competent to contract, hereby forms a Florida nonprofit corporation.

ARTICLE I Name

Article III General Purpose

The purpose for which this corporation is organized is exclusively for charitable activities as defined under the Internal Revenue Code; Section 501C3 which includes but is not limited to the following:

1. To sing, teach, preach, proclaim, publish, make known, distribute, and disseminate by oral, written or other means the Gospel of our Lord and Savior Jesus Christ and the teachings of the Holy Bible.
2. To travel wherever necessary, both domestic and abroad to foreign countries in order to support and encourage the extension of Christian life by preaching and teaching the Word of God.
3. To establish, ordain, commission and administrate missionaries, ministers and Christian workers who are in adherence with the purposes, policies and doctrines of this corporation.
4. To educate, counsel, and instruct people about the Holy Bible and all the information contained therein via multiple platforms including, conferences, seminars, workshops, study groups and meetings.
5. To engage in any such other business as permitted by law with approval of the Board of Directors.

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in the furtherance of section 501C(3) purposes.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate, or intervene in (including publishing or distributing of statements) any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501C(3) of the Internal Revenue code.

ARTICLE IV Directors

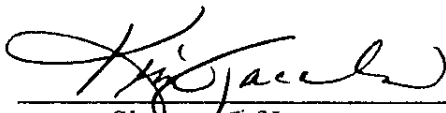

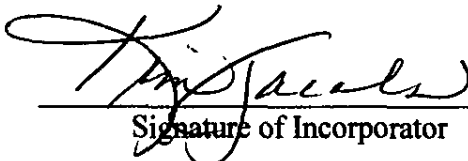
