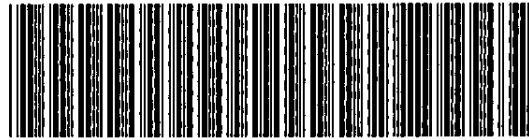

**ARTICLE I**
