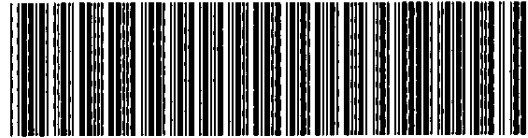

# Articles of Incorporation

## ARTICLE I NAME

The name of the corporation shall be The THY KINGDOM COME GLOBAL MINISTRIES, INC

## ARTICLE II PRINCIPLE OFFICE

The Principle place of business and mailing address of this corporation shall be: THY KINGDOM COME GLOBAL MINISTRIES, INC. 1122 Magnolia Ave Panama City, Florida 32401

## ARTICLE III PURPOSE

- a. The purpose of The THY KINGDOM COME GLORBAL MINISTRIES, INC is a non-profit organization. Organized exclusively for religious, charitable, educational purposes, including, for such purposes, the making of *distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code*; including but not limited to reaching up in worship, reaching out in Evangelism, reaching over in Discipleship. To grant license and ordain individuals as ministers of the Faith who subscribe to the principles set forth in our Articles of Faith. To encourage cooperation among local churches, congregations, or organizations with the same purpose as this corporation. To plant other churches in nearby communities and other states, expanding on the same *vision, mission, and purpose as this corporation*. To provide women with life skills training needed to support themselves and their children. To provide childcare services, to provide a half-way house to convicted men and women who are exiting the correctional system, providing them a place to stay, support to gain employment, education to make the needed life style changes, coping skills to assists them in life. To provide for an active

children's youth and young adult ministry; a place of meeting, develop meaningful life skills and provide opportunities for peer outreach.

- b. No part of the net earnings of the organization shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization for services rendered and to make payments and distribution in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organizations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of any candidate of public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- c. No substantial part of activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publication of distribution of statements) on behalf of any candidate for public office.

#### **ARTICLE IV      MEMBERSHIP**

The membership of THY KINGDOM COME GLOBAL MINISTRIES, INC shall be composed of Christians who accepted the Bylaws, teachings, doctrines, and government of THY KINGDOM COME GLOBAL MINISTRIES, INC as well, who have been formally received into its fellowship pursuant to the guidelines that have been established.

#### **ARTICLE V      DURATION OF CORPORATION**

The Corporation shall have perpetual existence.
