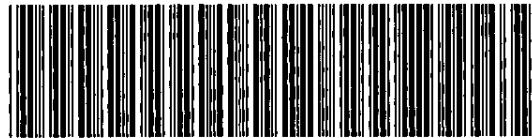

ARTICLES OF INCORPORATION
OF

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida do hereby certify:

ARTICLE I

The name of the corporation shall be EMERALD COAST VIZSLA CLUB, INC.

ARTICLE II

The principal place of business and mailing address of the corporation is 356 Whitfield Road, Freeport, Florida 32439.

ARTICLE III

This corporation is organized exclusively for:

- A. To promote cooperation and friendship among the breeders and owners of Vizslas; to encourage high standards in breeding for hunting ability and conformation; and to promote interest in training the Vizsla for field trials, hunt tests, obedience trials, agility, breed shows, gun dog and personal companion.
- B. To urge members and breeders to accept the standard of the breed as developed by the Vizsla Club of America and approved by the American Kennel Club as the only standard of excellence by which the Vizsla shall be judged.
- C. To work actively to protect and advance the interests of the breed by encouraging sportsmanlike competition at field trials, hunt tests, breed shows, agility and obedience trials.

- D. To conduct any or all of the following events as supported by the general membership of the club under the rules and regulations of the American Kennel Club including but not limited to sanctioned matches, dog shows, obedience trials, agility trials, tracking tests, hunting tests and field trials.
- E. To support research and educational work to reduce and/or eliminate detrimental congenital characteristics in the breed.

ARTICLE IV

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE VI

The Club may be dissolved at any time by the written consent of not less than 2/3 of the members in good standing. In the event of the dissolution of the Club, whether voluntary or involuntary or by operation of law, none of the property of the Club nor any proceeds thereof nor any assets of the Club shall be distributed to any members of the Club. After payment of the debts of the Club, its property and assets shall be given to a charitable organization.

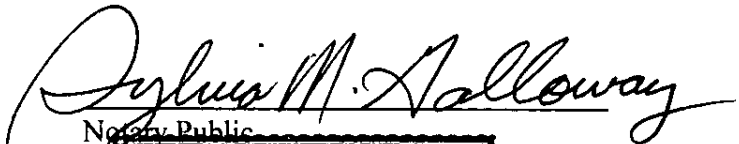

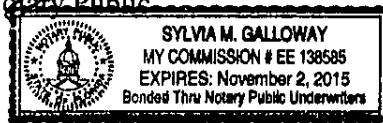

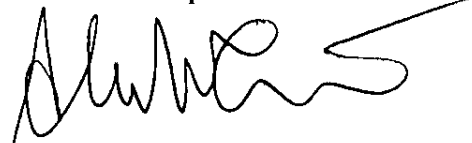
