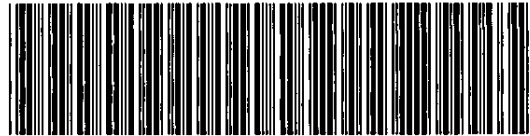

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

These Articles of Incorporations (the "Agreement") are made and effective January 22, 2012

Articles of Incorporation of: **Vision Walkers Ministries**

The undersigned, acting as the incorporators of the corporation under the Non for Profit Corporation Act of the State of Florida, adopted the following articles of incorporation for such corporation:

ARTICLE I - NAME

The name of the Corporation hereinafter referred to as "Corporation" shall be **Vision Walkers Ministries, Inc.**,

ARTICLE II - PRINCIPAL OFFICE

The principal office of the Corporation is:

ARTICLE III - PERIOD OF DURATION

This corporation shall have perpetual existence, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE IV - CORPORATE PURPOSE AND POWERS

The purpose for which the corporation is organized and operated are exclusively religious, charitable, literary and educational purposes with meaning of Section 501 (C)3, of the Internal Revenue code of 2011 or corresponding provision of any future United states Internal Revenue law.

SECTION 4.1- PURPOSE STATEMENTS

Our Purpose Statement is as follows:

To go out and teach people, far and near, God's Holy Word, baptizing them in the name of the Father, Son, and Holy Spirit to be empowered to partake in God's Great Commission right up to the end of the age.

- a) Religious purposes includes teaching, preaching the uncompromised Word of God, to train, disciple new converts and mature believers, reach lost souls, heal the sick and brokenhearted and provide spiritual counseling. Pursuant thereto the following:
 1. To conduct the ministry under the direction of the Lord Jesus Christ in accordance with all the Commandments and provision as set forth in the Holy Bible; the irrevocable Word of God.
 2. To Worship God in Spirit and Truth.
 3. To minister the Word of God within the ministry and to the community to promote encouragement and share the way to obtain eternal life; salvation through Jesus Christ.
 4. To baptize in the name of the Father, Son and Holy Spirit.
- b) Charitable purposes include giving charitable contributions to qualified organizations and to accept property and donations in trust for religious and charitable purposes.
- c) Literary purposes includes to spread the Word of the Gospel through seminars, book stores and other forms of media for purpose of educating the people in the Word of God.
- d) Educational purposes include schools for religious and educational instruction to the young and old. Child Care for religious, educational and social development to the young.

SECTION 4.2 -CORPRATE POWERS

As a means of accomplishing the above purposes and methods, the corporation shall have the power to license, ordain, and set forth ministers, pastors, evangelists, missionaries, in the ministry to provide training, counseling and education services necessary for the ministry, provided they are recommended by the ministry Pastor and these individuals must complete a training program set forth by the Pastor.

ARTICLE V - MANNER OF ELECTION

The provisions of the Bylaws of the Corporation shall govern the manner in which the Directors of the Corporation shall be elected or appointed.

ARTICLE VII- PROHIBITIONS

These are limitations to the activities of the corporation:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article four hereof. No substantial part of the activities of the corporation shall be dedicated to or otherwise attempt to influence United States or Federal legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII - DISSOLUTION

The manner in which assets will be distributed in the event of corporate dissolution:

Upon the dissolution of the corporation or winding up of its affairs, assets of the corporation shall be distributed to exclusively one or more religious, charitable, literary and educational organizations which would then qualify under provision of section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to

such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX- AMENDMENTS

These articles of incorporation may be amended at any time in the manner provided by the laws adherent to the jurisdiction of the State of Florida. By a majority of directors in the manner set forth in the Bylaws of the Corporation.
