

ARTICLES OF INCORPORATION OF

The undersigned, for the purposes of forming a corporation under the Florida Not Profit Corporation Act, and providing for the formation, rights, and privileges of corporations not for profit, hereby adopts the following Articles of Incorporation for such corporation;

ARTICLE I
NAME

The name of the corporation shall be **HARVELL'S CROSSING HOMEOWNERS' ASSOCIATION, INC.**, and its principal place of business shall be in the county of Santa Rosa, Florida, but it shall have the power and authority to establish any office or hold any meeting in any county of the state of Florida, at such places as may be designated by the Board of Directors.

ARTICLE II
EFFECTIVE DATE

The corporation shall begin its existence on Feb. 1, _____, 2012.

ARTICLE III
DURATION

The period of duration for this Corporation is perpetual.

ARTICLE IV
PURPOSE

The purpose of the Corporation is to engage in any business as permitted under the laws of the United States and the State of Florida, and to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes set forth herein and in the

Declaration of Covenants, Conditions, Restrictions and Easements for Harvell's Crossing, as amended from time to time, and the By Laws of the corporation.

ARTICLE V
CAPITAL STRUCTURE

The corporation, as a Florida non-for-profit corporation organized pursuant to Chapter 617, *Florida Statutes*, shall not issue shares of common stock.


ARTICLE VI
PRINCIPAL OFFICE
