**ARTICLES OF INCORPORATION
NOT FOR PROFIT**

Article 1. THE name of the corporation is N11,INC.

Article 2. The principal place of business and mailing address of the corporation is 230 B Sunrise Ave Palm Beach FL 33480.

Article 3. The specific purpose of the corporation is to prevent and eliminate hunger and malnutrition with food, nutrition and medical aid to disadvantaged children and families.

Notwithstanding other provisions in the Articles the purpose will be limited exclusively to exempt purposes within the meaning of IRC 501 (c) (3)

Article 4. The assets of the corporation are permanently dedicated to the exempt provision as set forth in Article 3 herein.

Article 5. In the event of dissolution any remaining assets after the payment of debts and liabilities will be distributed to a 501 (c) (3) organization whose purposes are identical to those of corporation established herein.

Article 6. The Members shall elect the Directors and the Directors shall name the officers the Directors shall enact as part of the By-laws of the corporation a conflict of interest policy for a 501 (c) (3) organization.

Article 7. The following persons will serve as the first Directors and Officers of the corporation.


