~~Amending Article III to say:~~ Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. In South Florida, students who attend the Public School System are required to wear mandatory school uniforms.

Our goal is to give a student an opportunity at the beginning of each school year to be a part of the learning environment by providing school uniforms. Although we primarily provide uniforms during the summer of each school year, we may provide them as needed. There are various Programs and Agencies which will identify students, in need of assistance, in some cases we may have the option of identifying students in need. NEB School Uniforms for Success Corporation is not designed to provide school uniforms for a student throughout their entire school experience, but to give various students the opportunity of being in the learning environment.

ADD ARTICLE IX TO SAY: Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

*ADD ARTICLE X TO SAY: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its Board Members, Trustees, Officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
