## ARTICLE III of the Articles of Incorporation for The Abaco Children's Foundation, Inc. PURPOSE is hereby amended as follows:

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The charitable corporation shall be operated to address the needs of endangered, orphaned and special needs children on the Island of Great Abaco and throughout the adjoining islands commonly referred to as The Abacos in the Commonwealth of the Bahamas. The Corporation shall cooperate with and provide service to the Department of Social Services of the Government of the Commonwealth of the Bahamas.

# ARTICLE VII of the Articles of Incorporation for The Abaco Children's Foundation, Inc. DISSOLUTION is hereby amended as follows:

In the event of the Dissolution of the Corporation, Articles of Dissolution, shall be prepared and submitted to the Department of State of the State of Florida. The Articles of Dissolution of the Corporation shall be prepared in accordance with Chapter 617 Florida Statutes and shall include a plan of distribution of the assets of the Corporation which plan shall provide that all liabilities and obligations of the Corporation shall be paid and discharged and upon dissolution of this Corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any further Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such charitable purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such charitable purposes.

The undersigned Assistant Secretary of the Corporation hereby states that at a meeting of the Officers and Directors duly noticed and held on March 9, 2012 at which meeting of the Officers and Directors of the Corporation were present, the foregoing Amendments to the Articles of Incorporation of THE ABACO CHILDREN'S FOUNDATION, INC. were approved by unanimous vote of the Officers and Directors of the Corporation then and there present.

There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors. The date of the amendment's adoption is March 9, 2012.
