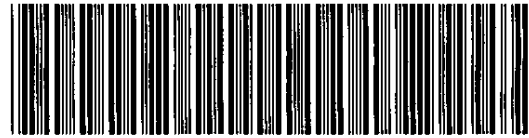

**AMENDED ARTICLES OF INCORPORATION
OF
PARS FORE PINK, INC.**

UNDER CHAPTER 617 OF FLORIDA STATUTES

THE UNDERSIGNED INCORPORATOR, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is PARS FORE PINK, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. PURPOSE

The specific purpose for which this corporation is organized is:

To provide support and comfort to people through the funding of preventative services, diagnoses and treatment of cancer related illnesses and financial assistance to community resources which provide services to such individuals.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or corresponding section of any future federal tax code.

ARTICLE IV. DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


