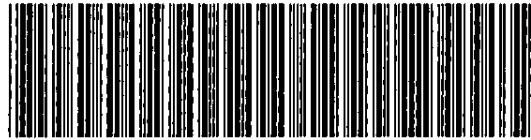

# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

## **ARTICLE I NAME** [The name of the corporation]

The name of the corporation shall be: Brevard County Division 2 of the Ancient Order of Hibernians in America, Inc.

## **ARTICLE III PURPOSE** [The purpose for which the corporation is organized]

The Brevard County Division 2 of the Ancient Order of Hibernians in America, Inc. is a Roman Catholic Irish heritage fraternity formed for fellowship and to support the Roman Catholic faith and members of her clergy by:

Supporting public events of an Irish heritage nature.

Supporting charities and charitable endeavors.

Providing education in Irish history and heritage.

Providing aid and support to Roman Catholic clergy.

## **ARTICLE IV MANNER OF ELECTION** [The manner in which the directors are elected]

The affairs of the corporation shall be managed by an executive committee of officers (directors) elected for a term of two years as stated in *Article IX, Section 1* and *Section 2* of The Florida Board of the Ancient Order of Hibernians in America, Inc. *By-Laws*:

### ***ARTICLE IX of The Florida Board of the Ancient Order of Hibernians in America, Inc. By-Lays***

#### **Divisions**

Section 1. The Division Officers shall be as follows: Elective; President, Vice President, Recording Secretary, Treasurer, Financial Secretary, Chairman of the Standing Committee, Marshal and Sentinel. Elected Officers shall serve for a two (2) year term or, in case of inability to serve, until such time as the Division has elected a replacement. No officer, except Recording Secretary, shall be eligible to succeed himself more than once.

### ***ARTICLE V of The Florida Board of the Ancient Order of Hibernians in America, Inc. By-Lays***

#### **Elections**

Section 2. Officers will be nominated and elected between October 1 and January 1. Installation of Officers will be conducted before January 31. Newly elected Officers will assume control in January. No member will be eligible for election to office unless a member in good standing of the AOH for a minimum of six (6) months and has received his Shamrock Degree, except for a newly formed Division.

**ARTICLE VIII DISSOLUTION**

Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office is located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE IX RIGHTS OF MEMBERS**

The members of this corporation shall have no rights, title or interest whatsoever in its income, property, or assets, nor shall any portion of such income, property, or assets be distributed to any member on the dissolution or winding up of this corporation. Members of this corporation shall not be personally liable for the debts, liabilities or obligations of the corporation and shall not be subject to any assessments.
