ARTICLES OF INCORPORATION

OF

WILD ABOUT BIRDS, INC.

(A Florida Not For Profit Corporation)

The undersigned incorporator, for the purpose of forming a Corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be:

WILD ABOUT BIRDS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be:

1798 Hideaway Lane Edgewater, FL 32132

<u> ARTICLE III - PURPOSE</u>

- A. The general nature and object of the Corporation shall be public environmental education focusing on conservation and preservation of habitats for the benefit of Florida's birds and other wildlife; and to provide a wildlife center with large outside enclosures for housing and display of permanent, non-releasable birds, and for physical reconditioning of rehabilitating birds prior to their release.
- B. The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

C. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The balance of all money and other property received by the Corporation from any source after the payment of all debts and obligations of the Corporation shall be used or distributed to other organizations whose goal is to provide environmental education, rehabilitation or reconditioning of birds and/or other wildlife, and which themselves are exempt organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal Government, or to a state or local government for public purpose.

The private property of the incorporator, officers or directions or this Corporation shall not be subject to payment of the Corporation's debts in any event or to any extent whatsoever.
