**ARTICLES OF INCORPORATION  
FOR  
THE NERDEL FOUNDATION, INC.  
(Not-For-Profit)**

The undersigned, desiring to form a charitable corporation under Chapter 617, Florida Statutes, as amended, the Florida Not for Profit Corporation Act, does hereby adopt the following Articles of Incorporation and certify:

**ARTICLE I  
NAME**

The name of the corporation shall be THE NERDEL FOUNDATION, INC.

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal place of business and mailing address of this corporation shall be 1000 West McNab Road, Pompano Beach, Florida 33069.

**ARTICLE III  
PURPOSE**

The corporation is organized exclusively for charitable purposes, to create, establish, operate and provide nutrition and fitness education for children in a web and general media format within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, either directly or through other charitable organizations.

**ARTICLE IV  
MANNER OF ELECTION**

The method of election of directors is as stated in the bylaws.

**ARTICLE V
