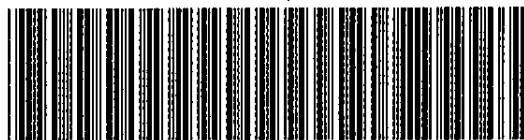



Articles of Incorporation rider

Article III Purpose

*** Second Chance** - Animals that have potential of being adopted, use of servicing the old and disabled, and/or use in the community as an aid in exercise, reading and therapy purposes; will be considered.

This organization's officers and directors will determine which animals are in their care.

**** Lack of Funding and/or adequate care** – Animals will be rescued from facilities that resort to euthanasia due to conflicts relating short supply of shelter, food, staff, lack of medical care; and neglect.

***** Offer education** – Awareness on health concerns and animal cruelty, while encouraging voluntary involvement of the community, will be conducted at Second Chances' charitable events.

Education will also be expanded to employees to handle duties of job.

****** In-house care** - Care will be based on the individual's needs. Therapy, exercise, rehabilitation and training will be care offered to their needs as well as the proper diet and veterinary care for each animal.
