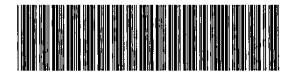

Article III is amended as follows:
A. This corporation is organized and operated exclusively for one or more of the following purposes: Charitable,

under 501(c)(3), Internal Revenue Code.

trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay
