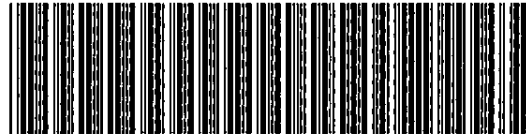

The undersigned incorporator, for the purpose of forming a Florida not-for-profit Corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

Article I The name of the Corporation is: **God Is My Light, Inc**

Article II The principal place of business and mailing address of the Corporation is:

8425 Delong Ave., North Port, FL 34291

Article III The purposes for which the Corporation is organized are:

This Corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or as hereafter it may be amended. More particularly, but without limitation, the purposes of this Corporation are:

(a) To organize as a church to educate and foster Humanity with the true Teachings and Testimony of the Two Anointed Ones of the Kingdom of God, found in the Law and the Prophets as revealed to Humanity by God through the descendants of Israel, for the charitable benefit of Humanity, as we have all things in common under God.

(b) To ordain, license, employ and discharge ordained and licensed priests to conduct and carry on the purposes of the Corporation at the places of worship of the Corporation, and elsewhere.

(c) To promote, encourage, and foster any other religious, charitable, and educational activities that are in compliance with the purposes of the Corporation; to accept, hold, invest, reinvest and administer any gifts, legacies, bequests, devises, funds and property of any sort or nature, and to use, expend, or donate the income or principal thereof for, and to devote the same to, the foregoing purposes of the Corporation.

(d) To do any and all lawful acts and things which may be necessary, useful, suitable, or proper for the furtherance of accomplishment of the purposes of this Corporation.

Article IV Board of Directors:

Plenary power to manage and govern the affairs of the Corporation is vested in the board of directors of the Corporation. The manner in which the directors are elected or appointed is provided for within the Bylaws of the Corporation.

Article V Publicly supported tax-exempt non-profit Corporation:

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VI Dissolution:

Upon the dissolution of the Corporation, the Corporation shall, after paying or making provision for payment of all the liabilities of the Corporation, distribute all of the assets of the Corporation to any organization designated by the Board of Directors of the Corporation which are of like faith and of exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
