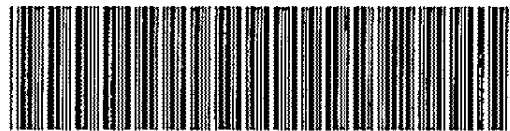

ARTICLES OF INCORPORATION

OF

CARING BY ANGELS FOR HAITI, INC.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a non-profit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of the CARING BY ANGELS FOR HAITI, INC. in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

ARTICLE I

NAME

CARING BY ANGELS FOR HAITI, INC.
(Hereinafter a non-profit corporation)

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

9606 Nellie Terrace
Clermont, FL 34711

The property and assets of this corporation are irrevocably dedicated to Religious, Charitable, Educational and Literary purposes.

ARTICLE III

PURPOSE

The purpose of Caring By Angels/a nonprofit organization, will provide welfare to the mentally ill, substance abusers, poor and distressed citizens of Haiti. The organization will distribute clothing, food and finances to citizens of Haiti to help decrease poverty in the region, and to increase the security in the country. Incorporation, is organized exclusively for religious, charitable, educational and literary purposes in the meaning of Section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. The Corporation is formed for religious and benevolent purposes and shall not be used for pecuniary gain or profit of its members. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the

Corporation shall not participate in or intervene in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from Federal income taxation under Section 501(c) 3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

The Corporation will not, as a substantial part of its activities, attempt to influence legislation (unless it elects to come under the provisions allowing certain lobbying expenditures) or participate to any extent in a political campaign for or against any candidate for public office.

ARTICLE IV MEMBERSHIP

There are no members for this not-for-profit corporation.

ARTICLE VII
INDEMINIFICATION

In addition to any rights and duties under applicable law, the Corporation shall indemnify and hold harmless all its directors, officers, employees and agents and former directors, officers, employees and agents from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such except for willful misconduct and gross negligence.

ARTICLE VIII
BYLAWS

Except as otherwise provided by law, the power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors.

ARTICLE IX
DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purpose of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or literary purposes as shall at the time qualify as an exempt organization or organizations under Section 501C3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the city or county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
