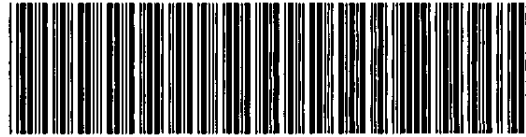

ARTICLES OF INCORPORATION

EDIBLE COMMUNITY GARDENS PROJECT, INC

Articles of Incorporation of the Edible Community Gardens Project, Inc

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the state of Florida do hereby certify:

ARTICLE 1 The name of the corporation is **Edible Community Garden Project, Inc.**

ARTICLE 11 The principal place of business is 915 Castile Plaza, Coral Gables, Florida 33134
The mailing address is 915 Castile Plaza, Coral Gables, Florida 33134, located
in Miami-Dade County.

ARTICLE 111 Said Corporation is organized for charitable and educational purposes including,
for such purposes, the making of distributions to organizations that qualify as
exempt organizations under section 501(c)(3) of the Internal Revenue code, or
the corresponding section of any future federal tax code.

PURPOSE

The specific purpose for which the corporation is organized is to plant, maintain and sustain an organic community garden with local residents and to create an educational, cultural and communal center. A center where all citizens can learn to grow organic home gardens and to prepare garden to table local food. The organization will promote sustainable environmental practices through activism, outreach and education.

ARTICLE 1V ELECTION OF OFFICERS OF THE BOARD

The Board Members will be elected by the members at the annual member meeting.

EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or to be distributable to it's members, trustees, officers , or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article three, hereof. No substantial part of the activities of the corporation shall be in the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, in or intervene in,(including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for political office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 © (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE VI

Upon the dissolution of the corporation, assets should be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or shall be distributed to the federal government, or to state and local government for a public purpose., Any such assets not so disposed of, shall be disposed of by a Court of Competent jurisdiction of the county in

which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
