Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States /desiring to form a Non-Profit Corporation under Chapter 617, F.S., do hereby certify: I ATTASSEE, FLORED A

ARTICLE I NAME

The name of the Corporation shall be Art Works 4 Food, Inc.

ARTICLE II PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is 101 Pugliese's Way, Delray Beach, Florida 33444.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
