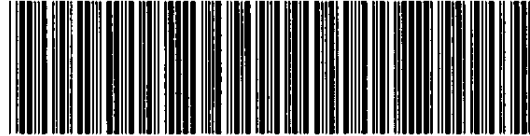

Risen Life Church, Inc.

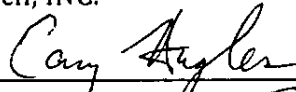
2. The foregoing amendment was adopted by the Directors of the Corporation on the 1st day of June, 2015.

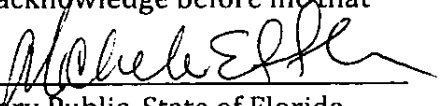
