

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Red Bay Community Center, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation shall be 10624 Rock Hill Road, Ponce de Leon, Florida 32455, and the mailing address of the corporation shall be 10624 Rock Hill Road, Ponce de Leon, Florida 32455.

ARTICLE IV - PURPOSES OF THE CORPORATION

The purpose of the corporation shall be to administer the use of the building for the sole purpose of operating and maintaining thereon a Community and Civic Center to be used for recreational, social, religious, and intellectual purposes and as a voting precinct for the citizens of the Red Bay Community area.

ARTICLE V - MEMBERSHIP

The members of the corporation shall be determined as provided in the By-Laws.

ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT




