# ARTICLES OF INCORPORATION

The Undersigned Incorporator, for the purpose of forming a corporation Under the Florida Not for Profit Corporation Act, in compliance with Chapter 617, F.S.

#### ARTICLE I NAME

The name of the corporation shall be:

CHAI MEDICAL CARE CENTER, INC.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Chai Medical Care Center, Inc is a program under Chai Community Services, Inc a non-profit 501C3 organization which provides medical attention to homeless veterans and poor disadvantaged individuals and families.

As part of its ongoing efforts to improve access to health care for homeless veterans and inner-city poor disadvantaged residents, Chai Medical Care Center Inc (CMCC) is offering Urgent Care medical assistance. We will be responsible for ensuring the general health of our patients and creating a viable and cost effective and eco friendly medical practice.

CMCC will focus on diagnosing and treating conditions of all ages from civilian walk-ins along with medical attention to homeless Veterans while emphasizing preventative medicine and the overall health and wellness of our patients. The clinic will utilize new equipment and a trained staff that will be able to optimize the care of each patient. CMCC understands that there are many factors that can affect health, including exercise, diet, environment and heredity. CMCC will try to provide the most comprehensive Urgent and wound medical care as possible in order to optimize the care and well-being of each patient.

CMCC will refer patients, when appropriate, to specialists and/or to hospitals for tests, further treatment and therapy.

The main objectives of Chai Medical Care Center is:

- To create a medical practice that will exceed patients' expectations.
- To provide high-quality health care to homeless veterans and residents of the area.
- To create a medical practice that helps serve the community's needs.
- To increase the number of patients by 20% per year through superior performance and word-of-mouth referrals.

The activities and services of Chai Medical Care Center, Inc. are available to all residents of the communities in which it serves without regard for income, race, color, national origin or handicap of the participants.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501C(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501C (3) of the Internal Revenue Code, or the corresponding section of any future tax code.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501C(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
