ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I - NAME

The name of the corporation shall be: EAGLES TRACK CLUB, INC.

The initial club officers shall be determined by majority vote of the members of the Eagles Track Club. The method of election of subsequent officers shall be determined by the bylaws of the corporation. The corporation will have members as described in the bylaws. The method of election of directors shall be determined by the bylaws of the corporation.
