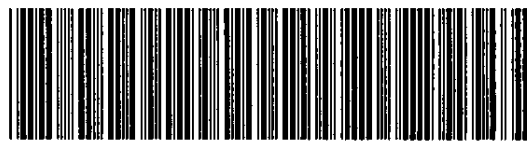

Add - Article VIII


