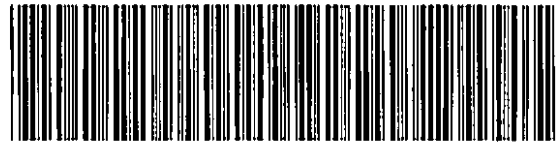

Article 3 The purpose Rose of Sharon Estuary, Inc. is organized for charitable, religious, educational and scientific purpose, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code. purposes within the Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code to the federal government or or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by Court of Common Pleas of the County in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 4 Form of Government

Each Director of The Rose of Sharon Estuary, Inc. shall have one vote. All voting at meetings shall be done personally no proxy shall be allowed. Only participating members, eighteen (18) years of age or older, will be eligible to vote on issues brought before the Board. There must be a 2/3rd majority vote of the Board to replace any open position.
