On February 2, 2013 an official board meeting was held to amend the Article of Incorporation of TWIS Deliverance Ministries, Inc. It was decided by the board of directors by unanimous vote "TWIS Deliverance Ministries, Inc" would amend Article 3: purposes and add Article 5: other Provisions to its Articles of Incorporation. The Articles are amended as following:

Article 3: Purposes

The corporation is a Church and shall operate exclusively for religious, charitable, educational and other purposes within the meaning of section 501(c) (3) of the United States Internal Revenue Code of 1986 (hereinafter "code"). As a means of accomplishing the foregoing purposes, the corporation shall have the power to engage in any lawful act of activity necessary or appropriate to the attainment of those purposes; provided, however, that notwithstanding any other provision of these Articles of Incorporation, the Bylaws, or any other provision of law, the corporation shall not have the power to carry on any activities which would cause it to fail to qualify, or to fail to continue to qualify, as (i) an organization exempt from federal income tax under section 501 (c)(3) of the Code, or (ii) an organization to which contributions are deductible under section 170 (c)2 of the Code.

Article 5: Other Provisions:

No part of the earnings of the corporation shall insure to the benefit of or be distributable to any private individual or person; provided, however, that the corporation may pay reasonable compensation for services rendered to it and reimbursement of expenses reasonably incurred on its behalf.
