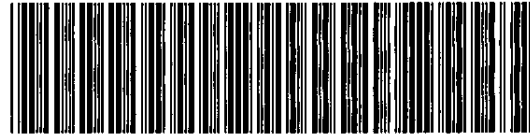

ARTICLE VIII DISSOLUTION
