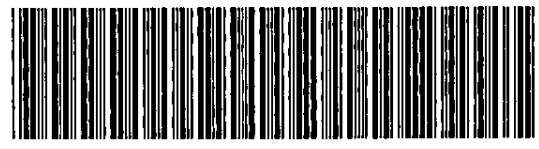

ARTICLES OF INCORPORATION
In compliance with Chapter 617.F.S., (Not for Profit)

Article I: Name

The name of the corporation shall be: **The Worship Center: Temple of Praise, Inc.**

Article II: Place of Business and mailing address

Principal place of business: 2585 Gomaz Way South
St. Petersburg, Florida 33712

The Corporate Mailing Address Shall Be the Same as Principal Address

Article III: Purpose

To offer spiritual enrichment, promote social enhancement, facilitate educational attainment and encourage community empowerment among people of all races, origin and nationalities. Promote love, respect and accountability among all people.

Article IV: Manner of Election

The manner of election for all offices other than the office of Chief Operating Officer shall be by open nomination and the casting of secret ballot with the majority being recognized as one count above the ballots cast. The office of Chief Operating Officer shall be a standing position with the succession appointed by the sitting Officer. All dissolution of assets shall comply with the dispersion of assets as provided by the IRS for non-profit 501 (c)(3) organizations.
