ARTICLE II

PURPOSE

The Corporation shall establish a temple or a worship center for its member to conduct religious activities such as worship and Adoration services, Bible Study, praying for the sick, teaching the words of God, and care for the needed in the community, establish school to educate its members and promote its beliefs. 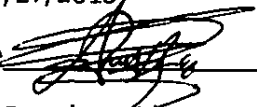
