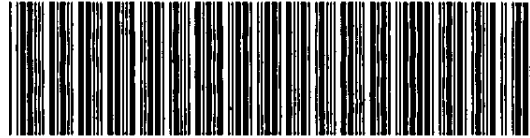

Add Article III: Said corporation is organized exclusively for charitable, education, and athletic purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code.

This organization is organized to foster national or international amateur sports competition.

To accomplish our purpose the organization provides dragon boat introduction classes that teaches paddling technique to individuals, groups, and

community teams representing a wide range of ages. When these paddlers learn the technique and become members then training focuses on developing teamwork among individuals. The organization helps team members to achieve their optimum level of performance and enjoyment of dragon boating. As performance, health and fitness improve members can elect to participate on a Nature Coast dragon boat team. The organization's membership is local or regional in nature as described in the bylaws.

The Nature Boat Dragon Boat Club Inc promotes public awareness and knowledge in the sport of dragon boating throughout Citrus and surrounding counties through news media, attending health fairs, special events, and social media. The organization provides officials (support staff) for dragon boat races and festivals.

Article VIII
