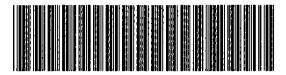

Articles of Corporation

DASCNA, INC.

Articles of Corporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Corporation shall be DASCNA, Inc...

Second: The place in this state where the principal office of the Corporation is to be located is: 3959 South Nova Road Port Grange, EL 32127

Third: DASCNA Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation is organized to coordinate the efforts of Narcotics Anonymous Groups in the Daytona Beach Area in carrying the message of Narcotics Anonymous. DASCNA Inc. will carry the message of Narcotics Anonymous by providing community public information services, telephone contact lines, various educational events and panel presentations to addicts in treatment centers and jails.

Fourth: The directors of DASCNA inc. are appointed and elected according to the bylaws of DASCNA, Inc. The names and addresses of the persons who are the initial directors of the Corporation are as follows:

Fifth: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying

on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under §501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the Corporation, assets shall be distributed in accordance to the fund flow structure of Narcotics Anonymous or for one or more exempt purposes within the meaning of §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Seventh: The name and Florida street address (P.O. Box NOT acceptable) of the initial Registered Agent is Richard M. Yunker, 3959 South Nova Road, Suite 16 Port Orange, FL 32127.

Eighth: The name and address of the incorporator is Richard M. Munker, 3959 South Nova Road, Suite 16, Port Orange, FL 32127.
