CHURCH OF God MISSIONARY FOR CHRIST INC. adopts the following amendment(s) to its Articles of Incorporation:

ARTICLE II

MAILING ADDRESS & PRINCIPLE PLACE OF BUSINESS

The mailing address of the corporation and its principal place of business shall be: 2615 North East 300 CT APT 103 BOYNTON BEACH FL 33435.

ARTICLE III

PURPOSE

CHURCH OF GOD MISSIONARY FOR CHRIST INC. is organized and operated exclusively for any lawful purse to retain non profit status as set forth in the most current Internal Revenue Code, and to act and operate exclusively as a not for profit Corporation pursuant to the laws of the State of Florida, its municipalities, county governments, and the United States. CHURCH OF GOD MISSSIONARY FOR CHRIST INC. is organized exclusively for charitable, religious, educational, and scientific purposes, helping poor people and street children in Haiti(missionary international) including, for such purposes, the making f distributions to organizations that qualify as exempt organizations under section501(c) (3) of the Internal Revenue Code, or corresponding section of any future

federal tax code. The Corporation shall be able to purchase and sell properties not for profit and if any profit is made to assist and help the community which it serves to achieve other charitable actions such as assisting members who are not financially stable to achieve goals that may render their lives a little better. The Corporation shall establish a temple or a worship center for its member to conduct religious activities such as worship and Adoration services, Bible Study, praying or the sick, teaching the words of God, and are for the needed in the community, establish school to educate its members and promote its beliefs. No substantial part of the Corporation shall be carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate or intervene in, including the publication or distribution of statement any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from the federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, corresponding section of any future federal tax code.

ARTICLE IX

DURATION

CHURCH OF GOD MISSIONARY FOR CHRIST INC. shall have a perpetual existence.

ARTICLE X

DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal code, or shall be distributed to the federal government or to a state or local government for the public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of organization is then located, exclusively for such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

CORPORATE POWERS

In addition to all other corporate powers provided by law and in furtherance of the objectives described in Art. III, but not in limitation thereof, CHURCH OF GOD MISSIONARY FOR CHRIST INC. shall have the power to:

- 1. Have succession by its corporate name for the period set forth in its Articles of Incorporation;
- 2. Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person;
- 3. Elect and appoint such as officers and agents as its affairs shall require and allow them reasonable compensation;
- 4. Adopt, change, amend and repeal bylaws, not consistent with law or its articles of incorporation; and the exercise of its corporate powers
- 5. Conduct its affairs, carry out on its operations, and have offices and exercise the power granted by Florida law in any state, territory, district or possession of the United States or any foreign country;
- 6. Purchase, take receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, otherwise deal in and with real or personal property, or any interest therein wherever situate;
- 7. Acquire, enjoy, utilize and dispose of patents, copyrights and trademarks and any licenses and other rights or interests thereunder or therein;
- 8. Sell, convey, mortgage, pledge, exchange, transfer or otherwise dispose of all or any part of its property and assets, lend, subscribe for, or otherwise acquire, receive, employ, shares and other interests in, or obligation of, other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships or individuals, or direct or indirect obligations of the United States, or any government, state, territory, or of any instrumentality thereof;
- Lend money for its corporate purposes invest and reinvest its funds, and take and hold real and personal property as security for the payments of funds, so loaded or invested;
