**No part of the earnings of INNER COURT OF DELIVERANCE CHRISTIAN CENTER, INC, shall inure to the benefit of/ or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles of incorporation.**

**Notwithstanding any other provision of these articles, INNER COURT OF DELIVERANCE CHRISTIAN CENTER, INC., shall NOT carry on any propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the Publishing or distribution of statements) and any political campaign on behalf of or in opposition to any other activities not permitted to be carried on (a) by a Religious, Charitable and Educational not for profit corporation exempt from federal income tax under Section 501 (c) (3) of the Code of 1986 or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Code.**

#### **DISTRIBUTION UPON DISSOLUTION**

**Upon the dissolution or winding up of INNER COURT OF DELIVERANCE CHRISTIAN CENTER, INC can only be done by the express will of the Executive Board of Directors, decree of Court, or bankruptcy. In such a case, all efforts shall be terminated and all assets shall be liquidated in order to satisfy creditors. Any remaining assets will be donated to other not for profit corporations that are exempt within the meaning under section 501(c)3. Any such assets not disposed shall be distributed by the Superior Court in the county which the Corporation reside to a not for profit corporation which has established its tax exempt status under the internal Revenue Code section 501c3.**


**ARTICLE IX Authority of the Corporation**


