Articles of Incorporation

In compliance with Chapter 617, F.S. (Not for Profit)

Article I - Name

The name of the Corporation Not For Profit shall be Linden Place Homeowners' Association, Inc. and the effective date of the Corporation shall be the date of acceptance of these Articles of Incorporation by the Florida Department of State.

Article II - Principal Office

The principal office of the Corporation will be located at 10088 Linden Place Drive, Seminole, Florida 33776.

Article III - Purpose

This purpose of this Corporation is not for profit and shall be to enforce the covenants and deed restrictions as set forth in the Linden Place Restrictions, signed on February 16, 1977 and entered into the Pinellas County Court Record on February 17, 1977, and all subsequent revisions and amendments duly passed in accordance with these Restrictions.

The Corporation shall maintain and provide for the maintenance of all of the common areas associated with the Linden Place residential area and to enhance and improve all such common areas as the Association may desire. This maintenance shall include, but not be limited to street lighting, perimeter fence maintenance, and common area grounds keeping and landscaping.

The Corporation shall determine the amount of annual dues, collect the annual dues, levy and collect assessments, and place liens on properties as required to enforce the Restrictions and Covenants and to provide for the maintenance of all common areas within the Association, as well as any and all powers and duties required and stipulated in Florida Statutes 720.303.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Statement of Purpose hereof. The property of this Corporation is irrevocably dedicated to the enforcement of the covenants, providing for the maintenance, enhancement, and improvement of the Association's common areas, and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

Article IV: Election of Corporate Directors

The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than five (5).
