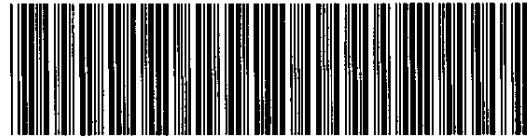

ARTICLES OF INCORPORATION  
FOR  
IMMIGRATION INFORMATION ADVOCATES, INC.**

The undersigned incorporators of a corporation for the purpose of forming a Florida not-for-profit, pursuant to Florida Statutes Chapter 617, adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the Corporation is:

**Immigration Information Advocates, Inc.**

**ARTICLE II - LOCATION**

The principal place of business of the corporation shall be:

The mailing address of the corporation and its registered agent is:

**ARTICLE III - PURPOSE**

The corporation is organized exclusively for charitable purposes under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The charitable purposes are to seek all means to provide information to the public about why there is a need for immigration reform. To do all things necessary and appropriate for carrying out and exercising the foregoing purpose.

**ARTICLE IV - MEMBERS**

The Corporation shall have only one class of members. It shall be totally comprised by its directors. The manner in which directors are elected or appointed is as follows:

The affairs of the Corporation shall be managed by a Board of Directors. The number of Directors constituting the initial Board of Directors shall be four (4); thereafter, the number and manner of election or appointment of Directors and their terms of office shall be as provided in the By-Laws, but the number of Directors shall not be less than three (3).

**ARTICLE V - POWERS**

In order to promote its purposes, this corporation may seek and receive grants of money from the public and private sources, acquire property by gifts, grants, or purchase.

#### **ARTICLE VI – NON-PROFIT STATUS**

The Corporation is not organized for pecuniary profit and shall have no power to declare dividends. No part of its net earnings shall inure to the benefit of any member, director, or individual. The balance, if any, of all money received by the corporation from its operations after payment in full of all operating expenses, debts, and obligations of the Corporation of whatsoever kind and nature as they become due shall be used to make advance payments on loans owed by the corporation, or for some related purpose. No member, director or officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the Corporate assets on dissolution of the Corporation.

The specific purposes for which the Corporation is organized are charitable within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States internal Revenue Law, hereinafter the "Internal Revenue Code").

Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not carry any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### **ARTICLE VII – INITIAL REGISTERED AGENT AND OFFICE**

#### **ARTICLE X – BY-LAWS**

The power to adopt, alter, amend, restate or repeal By-Laws shall be vested in the Board of Directors.

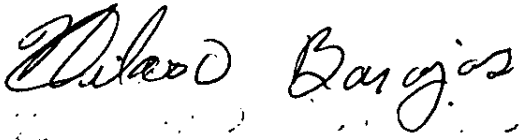
