Articles of Incorporation

Of

Chrysalis Chamber Players, Corp.
A Florida Not-For-Profit Corporation

Article I

NAME

The name of this Not-For-Profit Corporation shall be Chrysalis Chamber Players, Corp.
(hereinafter called the "Corporation").

Article II

DURATION

The duration of the Corporation shall be perpetual.

Article III

PRINCIPAL OFFICE AND/OR MAILING ADDRESS

The address of the principal office and/or the mailing address of the Corporation is 776
96th Ave. North, Naples, Florida, 34108.

Article IV

PURPOSE

This Corporation is a not-for-profit corporation, organized for charitable and educational purposes as defined in Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and for the purpose of engaging in any lawful act or activity for which corporations may be organized under the laws of State. The specific purpose for which this Corporation is organized is to provide unique music programs to audiences in south Florida, and to educate young artists of all levels.

Article V

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 776 96th Ave. North, Naples, Florida, 34108; and the name of the Corporation's initial registered agent at that address is Mary Elizabeth Bowden.

Article VI
BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) directors. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner of election of the directors shall be regulated by the Bylaws.

Article VII
MEETINGS

After incorporation, the appropriate members of the Corporation shall hold an organizational meeting in accordance with Chapter 617, Florida Statutes, as amended.

Article VIII
DISSOLUTION

Upon the dissolution of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX
LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or

otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of 501 of the Internal Revenue Code, or the corresponding section of any future federal tax code, and the Corporation shall not participate or intervene in (including the publishing and distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

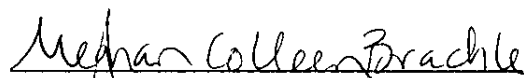

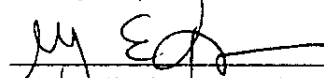

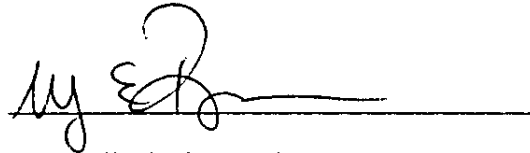
