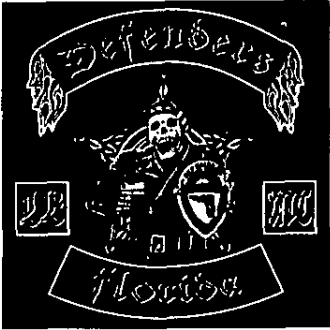

## ARTICLE III: PURPOSE

The purpose for which the corporation is organized:


