

ARTICLES OF INCORPORATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Processian Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article 1: The name of the Corporation shall be Tutors for Kids, inc.

<u>Article II</u>: The place in this state where the principal office of the Corporation is to be located is the City of Summerfield, Marion County, Florida at 12085 SE 175th Loop.

<u>Article III:</u> Tutors for Kids, Inc. is a community-based organization of volunteers who support the local educational process through direct classroom tutoring and other activities that enhance the educational environment leading to scholastic advancement

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes as, the making of distributions to organizations, such as:

- Local public schools,
- Those that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or
- Other organizations qualified under corresponding sections of the federal tax code.

<u>Article V</u>: The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.

<u>Article VI</u>: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

Article IX: Upon the dissolution of Tutors for Kids, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government or public school, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
