The Articles listed herein, form part of the initial Articles of Incorporation for the  
**Hialeah Miami Lakes Republican Club, Inc.**

**ARTICLE VIII – ADDITIONAL TERMS**

- (A.) **NO PRIVATE INUREMENT:** The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits, or dividends to the Directors, Officers, or Members thereof, or to any individual. The property, assets, profits, and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
- (B.) **DISSOLUTION:** Upon dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as a non-for-profit entity. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney general or any person concerned in the liquidation.
- (C.) **INDEMNIFICATION:** Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such Director or Officer (or such heirs, executors or administrators) may be entitled apart from this Article.
- (D.) **ALTERATION OF ARTICLES:** These Article of Incorporation may be altered, amended, or repealed and new Articles may be adopted by a two-thirds majority vote of all Directors at a properly called meeting of the Directors. At least seven days' written notice setting forth the proposed action and specific Articles to be added, deleted, amended, or changed and the time and place of the meeting shall be given to all members of the Board of Directors.
