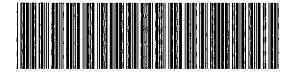

ARTICLES OF INCORPORATION

<u>OF</u>

EMERALD LAKES SOCIAL CLUB, INC.

The undersigned, acting as Incorporator of this corporation, hereby adopt the following Articles of Incorporation for the purpose of forming a not-for-profit corporation under and by virtue of the laws of the State of Florida as contained in Chapter 617, Florida Statutes.

ARTICLE I. NAME

The name of the corporation shall be EMERALD LAKES SOCIAL CLUB, INC. and the initial principal office and mailing address of the corporation shall be located at 1401 W. Highway 50, Clermont, Florida 34711.

ARTICLE II. DURATION

The date of commencement of corporate existence shall be on the date the Articles are filed with the Department of State, and the period of duration of the corporation shall be perpetual.

ARTICLE III. PURPOSE AND POWERS

The specific and primary purposes for which the corporation is organized are:

A. To sponsor, support and conduct recreational and social activities for the residents

of the Emerald Lakes Manufactured Housing Community in Clermont, Florida.

ARTICLE IV. MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the Bylaws of this Corporation.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT
