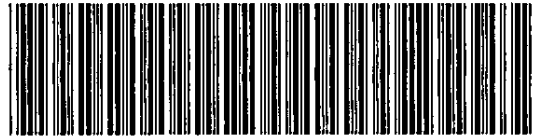


## Addendum to Articles of Incorporated
